Role overview

Reporting to the Home registered manager, you will be a core member of the Swanborough House team. The purpose of this role is to deliver a structured programme of regular, varied and meaningful sessions such as external trips, relaxation, gardening, crafts and musical interventions for well-being, to appeal to the interests and suit the capability of the service users.

Individual and groups sessions organised and the degree to which service users can participate may be varied and the Activities Coordinator will work with a person-centred care approach.

Key responsibilities

- Prepare and distribute a monthly programme of activities.
- Plan sessions ensuring they are person-centred, taking into consideration service users' preferences, cabaility, capacity, cultural, ethnical, and religious background.
- Contribute to service users' timetables and keep timetables up to date.
- Liaise with relevant staff prior to an event to give them details of requirements.
- Liaise with therapists and team members regarding sessions and the goals for individual service users.
- Network with community contacts, e.g. religious leaders, PAT animals, theatres, and other charitable and/or voluntary organisations.
- Record details of sessions attended by each service user in a timely manner.
- Immediately report any changes (physical or mental) in a service user's condition to the person in charge.
- Lead and/or participate in group sessions independently, or where appropriate, jointly with therapists and care team.
- Actively encourage service users to attend sessions and ensure their transfer to the venue.
- Organise monthly themed events.
