Role overview

Reporting to the Site Clinical Psychologist/Head of Therapies, you will be a core member of the AHP team, providing a psychology service to an often-complex case, both in group format and individually.

You will work under the direction of the Site Clinical Psychologist/Head of Therapies, alongside the wider AHP team. To support and enhance the professional rehabilitation of clients within the service, their relatives and carers, and all others who make use of the service, as part of an inter-disciplinary team. To primarily provide: psychological assessment and interventions under the clinical supervision of Clinical Psychologist, working independently according to a plan agreed with a qualified clinical psychologist and within the overall framework of the team and company policies and procedures. To assist in clinically related administration, conduct of audits, collection of statistics, development of audit and/or research projects, teaching and project work as required.

Key responsibilities

- To assist in the formulation and to independently deliver agreed care plans involving the psychological treatment and/or management of a service user's problems, under the supervision of a qualified clinical psychologist, in the hospital and across other settings, as required.
- To assist the IDT in the coordination and development of therapeutic and psychoeducational groups, and to deliver these groups under the supervision of a qualified clinical psychologist.
- To undertake protocol based psychological assessments of clients applying psychological, including neuropsychological, tests, self-report measures, rating scales, direct and indirect structured observations and semi-structured interviews with service users, family members and others involved in the patients care.
- To prepare test materials and visual aids, and have delegated responsibility for the upkeep of all assessment material and teaching, rehabilitation and therapy resources, in liaison with qualified clinical psychologist.
- To undertake clinically relevant administrative duties as required.
- To maintain accurate and comprehensive patient assessment and/or treatment records in accordance with professional codes of practice of the British Psychological Society and company policies and procedures.
- To contribute to writing client assessment and/or treatment review reports in accordance with professional codes of practice and company policies and procedures.

- To assist in the development of a psychologically based framework of understanding and rehabilitation to the benefit of all clients of the service, across all settings where the service is provided.
- To attend and contribute to appropriate inter-disciplinary meetings as required.
- To participate in providing training and support to professionals and carers within the hospital and outside the hospital on topics relevant to acquired brain injury and neuro-rehabilitation.
- To actively participate in the dissemination of relevant clinical research and case-related material
